Re: Meeting with Owen Glenn 22 December 2006

Date: 29 August 2008

I have read what has been reported in the media by those who are trying to read between the lines. This memo may add some clarification to the confusion.

I recall a certain meeting between Owen Glenn and yourself - Friday 22 December 2006.

You and I were having a late lunch at Portofino in Viaduct Basin Auckland.

You were expecting Owen to pop by for a drink as it was informally arranged.

Before you introduced me to Owen you talked amongst other things, his interests in racing and horses.

When Owen arrived, you both engaged about the Australian and Dubai racing industry, their success, the prize money and the failings of New Zealand's racing and breeding industry. You talked about your vision for New Zealand racing and your plans to make changes in the near future.

I recall you and Owen debating ideas on how best to remedy the industry. You challenged Owen to help you support the NZ racing industry with arriving at solutions to help solve the problems.

Owen asked you, how can he do this? One of the key things you said – New Zealand cannot match the big prize stakes of Australia and Dubai. You both discussed a number of ideas. You asked Owen to put up some money to help fund a meeting / conference of relevant people (some of which you both threw into the conversation) to get together and work on strategies to get New Zealand's racing / breeding industry back on track.

You challenged Owen how was he prepared to help. Owen offered you \$100,000 to fund this conceptual meeting/conference you both came up with, to bring people together from around the region. Owen asked you to come back to him with a plan.

I dropped Owen off at the Hilton where he was staying. Owen introduced me to his partner.
